## Establishment of a Regional Management Company in China

Targeting expansion of its business in China and strengthening of its overall group management, Mitsui Chemicals, Inc. (“MCI”), with its Head Office in Tokyo, Japan, (Tsutomu Tannawa, President & CEO) established Mitsui Chemicals (China) Management Co., Ltd. (“new company”) by reorganizing Mitsui Chemicals (Shanghai) Co., Ltd on July 1<sup>st</sup> 2014.

On August 6<sup>th</sup>, the new company received certification from the City of Shanghai as a multinational corporation (“MNC”) regional headquarters under “Provisions of Shanghai City on Encouraging the Establishment of Regional Headquarters by Multinational Corporations” which offers incentives for investment by foreign MNCs.

In addition, establishment of the new company will make the MCI Group eligible for incentives, such as financial assistance, from the City of Shanghai.

The Group will continue efforts to expand and strengthen its business in China, with a focus on the new company, by supplying cutting edge, performance driven products to its customers in China.
